Filosofie magisterexamen uppnås efter fullgjorda kursfordringar om sammanlagt minst 160 poäng. I dessa poäng ingår minst 80 poäng i huvudämnet varav 20 poäng utgör examensarbete. Kursernas omfattning anges av poängtalet, varvid 20 poäng motsvarar en termins heltidsstudier.

A Master of Social Science degree is awarded after completion of courses carrying a total of least 160 credit points (4 years of study). The major subject carries 80 of these credit points and includes a 20-credit points degree assignment. One credit point is equivalent to one week of full-time study, and an academic year comprises 40 credit points.

- 3.2 **Official length of programme:** At least 160 credit points (240 ECTS credits). The scope of undergraduate education shall be stated in accordance with a credit system, where each credit corresponds to one week's full-time study.
- 3.3 **Access requirement(s):** General eligibility is attained by completing an upper secondary school programme and obtaining a pass grade or better in at least 90 per cent of the courses required in the programme, or by providing proof of an equivalent level of knowledge. The specific eligibility (requirements) vary according to the field of higher education and are expressed in terms of subjects in the upper secondary school.

4.1 **Mode of study:** Full-time equivalent.

4.2 Degree requirements

Central Regulations:

Scope:

A Master of (Magisterexamen med ämnesdju) shall be obtained after completing the course requirements of at least 160 credit points. Advanced studies are required in the main subject at the 80-credit point level, with passing grades.

Objectives:

The general objectives set out in chapter 1, section 9 of the Higher Education Act and the objectives determined by the institution of higher education concerned.

Miscellaneous:

In order to receive a degree of Master (Magisterexamen med ämnesdju), the student shall have completed an independent project (degree project) of at least 20 credit points or two such projects of at least 10 credit points each. This project (these projects) shall be part of the main subject studied. Credit may be given for 40 credit points from doctoral studies in the main subject.

The main specialisation of the degree shall be stated in the degree certificate.

Local Regulations:

The student shall in order to achieve a degree of master have completed studies of 20 credit points in a subject different from the main subject.
